
WHEREFORE, we, the Bids and Awards Committee resolved as it is hereby resolved:


1. To recommend award to **SAVIOUR MEDVICES, INCORPORATED** with the Lone Complying and Responsive Bid.
2. To recommend approval of this resolution by the Medical Center Chief II


