INVITATION TO BID

1. The Dr. Jose Fabella Memorial Hospital, through the GAA 2016 intends to apply the following amount being the approved budget for the procurement of the item below:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
4. Interested bidders may obtain further information from Dr. Jose Fabella Memorial Hospital and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.

A Complete set of Bidding Documents may be purchased by interested Bidders upon payment of nonrefundable fee for the Bidding documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.


5. The Dr. Jose Fabella Memorial Hospital will hold a Pre-Bid Conference on **June 8, 2016, 2:00 p.m. at CFPS Conference Room**, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. Bids must be delivered to the address below which must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **June 21, 2016, 2:00 p.m. at CFPS Conference Room**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The DJFMH reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
